Keynote Presenter: Ellen Flannery-Schroeder, PhD

Professor, Director of Training in Clinical Psychology, Dept. of Psychology and Director of the Pediatric and Adolescent Anxiety Lab (PAALs) at the University of Rhode Island

She has dedicated her career to preventing and treating childhood anxiety.
