1. Real Family Engagement: More than offering coffee and cookies

- What is family engagement and why is it important?
- Which national models are successful?
- What key strategies can stakeholders use to engage families?

The lecture will discuss the similarities between "Family/School/Community Engagement" used in schools and "Family-Centered Practices" used among health and human service providers. It will also discuss how to build a common language and set up expectations, and strategies for professionals to engage families.

E. Belle Evans, PhD, MSW, LICSW, MPH, MEd, BSN, RN, BS, is a Professor of Social Work at Rhode Island College. She has had a long and varied career in both the maternal/child and mental health fields. Areas of expertise include: health, child care, aging, disabilities, mental health, and trauma.

Deborah Belanger is the Training and Professional Development Manager at RI Parent Information Network (RIPIN). She has 26 years experience raising a son with autism and bipolar disorder and 23 years experience advocating for students with special needs in Rhode Island.

Family Voice: Anne Babineau is a RIPIN Family Resource Specialist in a Westerly pediatric practice. She is the parent of 2 children, one with multiple disabilities. Anne is a former journalist whose essays about raising a daughter with Asperger's syndrome have been aired on National Public Radio.

2. Overcoming Resistance & Denial: Honoring family values and acknowledging past experiences

- How to incorporate into treatment capacity to cope with life stressors
- How to use motivational interviewing techniques to engage families
- How to proactively identify and establish plans to resolve barriers to treatment

This lecture will focus on a number of promising approaches to improve family engagement that involve detecting families at pretreatment who are at risk of poor engagement and tailoring initial interactions to address negative expectation, attend to potential barriers and build readiness.

3. Maximizing Family Strengths: Setting children up to succeed

- How to identify family strengths and build plans based upon them?
- What is CDOI (Client-Directed, Outcome-Informed) therapy?
- What are the techniques practitioners can use in their everyday work?

Using a family systems approach, this discussion will focus on identifying & utilizing family strengths to support children, including strategies for partnering with families and avoiding adversarial relationships. Principles of CDOI therapy will be shared as a way to engage families more fully in change efforts.
